Neelima Palacherla from LAFCO handed out brochures, "What is LAFCO?" and "Santa Clara County and Cities Boundaries Maps." They are starting to distribute to the affected agencies members of the public and community organizations. LAFCO offered to do a presentation at the March meeting.

She also provided an update on the Rancho Rinconada Recreation & Park District special study. Due to unexpected staff turnover at the City of Cupertino there has been a delay with the study. The City of Cupertino does have a new interim Director of Parks and Recreation, LAFCO is waiting on a date from the City to know when they can move forward.

LAFCO Meeting scheduled for this Wednesday, 12/4 and the Agenda is posted on their website.

2. California Special Districts Association – Mustafa Hessabi

Mustafa Hessabi from California Special Districts Association (CSDA) handed out information on their 2019 major accomplishments and gave a brief overview of the accomplishments. Held first Special District Week in 2019. Looking to propose another in 2020. They also provided a brief overview of who CSDA collaborates and partners with on lawsuits that affect special districts and their process.

CSDA recently did a Public Safety Power Shutoff Survey and requested the participation of the membership. Rachael Gibson from Valley Water mentioned that Valley Water has completed the survey and that it was very easy and recommends everyone else submit as well.

H. Santa Clara County Special District Association Member Reports

- S. Wesolowski: Rancho Rinconada Recreation and Park District reported on a successful year and is looking for candidates to fill open positions.
- J. Crawford: South Santa Clara County Fire District provided a response back on a draft study for a Management Audit conducted by the County Board of Supervisors. The report should be coming out from the County Board of Supervisors soon. Also, they are finishing up a study for Morgan Hill, Gilroy and South County. They have 40 finding and 10 recommendations. - L. LeZotte: As the flood protection agency, Valley Water is gearing up for the rainy season. Asked everyone to report downed trees or creek blockages and crews will be sent out as needed.

F2. Amendment to Bylaws

ARTICLE X.

LEGISLATIVE POSITIONS

Section 1. Because SCCSDA consists of diverse special districts with different missions, responsibilities, and authorities, the Board of Directors is precluded from taking a position on any legislation or ballot initiative unless it is one sponsored by the California Special Districts Association (CSDA). If CSDA requests a position on their sponsored legislation or ballot initiative, the Board of Directors may only take action if the following criteria are met:

- A. The representative for the member agency has been given a 30-day notice of the legislation or ballot initiative before it is scheduled for a vote to ensure adequate time to obtain feedback from the representative's governing authority;
- B. The proposed position is not in opposition to one taken by CSDA, as set forth in the agreement between CSDA and SCCSDA; and
- C. The legislation or ballot initiative has an impact on member or special districts generally rather than on an individual district, or a class or type of special district.

Section 2. Members of dependent special districts shall have the option of not participating in a position vote in deference to their oversight agency. If a member district exercises this option, it will not be counted or included in the Board's vote or discussion, but its representative may make comments as a public member.

Section 3. Any vote to take a position on legislation or a ballot initiative will have the approving and dissenting individual member districts' votes recorded in the minutes.

Section 4.

<u>Original proposal:</u> This section does not preclude individual member districts from taking their own respective positions on legislation and/or ballot initiatives affecting special districts. The SCCSDA shall help facilitate such requests by making available the contact list for SCCSDA member agency representatives to any representative making the request.

Revised proposal: This section does not preclude individual member districts from taking their own respective positions on legislation and/or ballot initiatives affecting special districts. Individual member districts also may choose to present information regarding legislation they are sponsoring during the Member Roundtable section of the agenda, although they may not ask for a vote of the membership. If requested, the SCCSDA will make available the contact list for SCCSDA member agency representatives to any member making the request.
